WHEREAS, the Vineland Free Public Library has requested the City of Vineland to continue to retain certain dedicated funds of the Vineland Free Public Library for the purpose of paying salaries, compensation, and benefits of the employees of the Vineland Public Library;

WHEREAS, the City of Vineland has indicated a willingness to continue to do so;

NOW THEREFORE, BE IT RESOLVED, by the Vineland Free Public Library Board of Trustees that the City of Vineland is permitted to retain certain dedicated funds of the Vineland Free Public Library for the purpose of paying employee salaries and benefits for the Vineland Free Public Library during the calendar year 2026; and

BE IT FURTHER RESOLVED by the Trustees that this resolution shall be effective immediately and be effective through January 31, 2027.

**RESOLUTION AUTHORIZING THE BOARD TO GO INTO EXECUTIVE SESSION TO
DISCUSS THE COLLECTIVE BARGAINING AGREEMENT**

WHEREAS, N.J.S.A. 10:4-2 (b) (4) provides that a public body may exclude from public discussion matters “involving “collective bargaining agreement[s], or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body....”


WHEREAS, the Board of Trustees of the Vineland Free Public Library propose to discuss terms and conditions of the collective bargaining agreement with IBEW Local 210.

NOW, THEREFORE, BE IT RESOLVED, by the Trustees of the Vineland Free Public Library that the Board go into Executive Session, closed to the public, to discuss the collective bargaining agreement with IBEW Local 210.

BE IT FURTHER RESOLVED, that the discussion concerning the collective bargaining agreement with IBEW Local 210 may be disclosed to the public at such time as the purpose for the exclusion of the public will not be circumvented, but in no event any sooner than six (6) months from the date of the hearing.
