

**A RESOLUTION DESIGNATING OFFICIAL
NEWSPAPERS FOR THE VINELAND
PUBLIC LIBRARY FOR CALENDAR YEAR 2026**

WHEREAS, the Vineland Public Library (the "Library") finds and determines that (a) the Library is required to provide public notice of certain actions, solicitations, and other matters as may be required by applicable law, and (b) designating official newspapers for the publication of such notices complies with applicable law and promotes transparency, accountability, and timely public access to information.

WHEREAS, this Resolution is adopted pursuant to the Library's authority under applicable New Jersey law, including, as applicable, the New Jersey statutes governing (i) publication of legal notices and designation of official newspapers, and (ii) public contracting and notice requirements, including the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., and the statutes governing publication of legal notices, including N.J.S.A. 35:1-1 et seq., as each may be amended and supplemented (collectively, the "Applicable Notice Laws").


NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Vineland Public Library as follows:

1. "Notice" means any advertisement, legal notice, request for bids, request for proposals, request for qualifications, meeting notice, award notice, or other publication the Library determines is required or advisable to publish in a newspaper of general circulation, whether mandated by the Applicable Notice Laws or otherwise.
2. For Calendar Year 2026, the Library hereby designates the following as its Official Newspapers:
 1. The Daily Journal
 2. The Press of Atlantic City.
 3. The Vineland Voice
3. The Official Newspapers are authorized to publish Notices on behalf of the Library during Calendar Year 2026, as directed by the Library. The Library may publish a Notice in one or more Official Newspapers, as needed to meet legal requirements and to inform the public.
4. The Library may direct that a Notice be published in one or more Official Newspapers, as the Library determines is necessary or appropriate to comply with the Applicable Notice Laws, to achieve adequate public dissemination, or to satisfy any specific publication instruction applicable to the particular Notice.

5. If a specific statute, regulation, or other binding legal requirement applicable to a particular Notice mandates publication in a particular newspaper, format, frequency, timing, or geographic circulation, the Library shall comply with that requirement, and this Resolution shall be construed to permit such compliance without further action
6. The Library shall require, and the Official Newspapers shall provide upon request, customary proof(s) of publication (including affidavits or certifications of publication) for each Notice published.
7. The Library shall maintain proofs of publication and related documentation in its records in accordance with applicable record retention requirements and the Library's policies, as may be amended from time to time.
8. This designation shall be effective for Calendar Year 2026 only, unless modified or rescinded by subsequent resolution of the Library.
9. If, during Calendar Year 2026, any Official Newspaper is unable or unwilling to publish a Notice within the time required by law or by the Library, or if publication in any Official Newspaper would not satisfy the Applicable Notice Laws for a particular Notice, the Library may direct publication in one of the other official newspapers.
10. If any provision of this Resolution is held invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect to the maximum extent permitted by law, and shall be construed to effectuate the Library's intent to comply with the Applicable Notice Laws.
11. This Resolution shall take effect immediately upon adoption.
